J.B. and his family were instrumental to the establishment and building of Seamark Ranch. Generous not only with his financial resources, J. B. made his company resources, J.B. Coxwell Contracting, available to accomplish anything needed - from building roads, installing drainage, to hauling dirt for building homes and buildings. When J.B. put his name to something he was going to get it done as evidenced by the growth of Seamark Ranch to date.

#### But it was his love for children and his desire for each to have the best life possible that drew J.B. and indeed the entire Coxwell family to champion Seamark Ranch.

From poor beginnings as one of eight children of an Alabama sharecropper J.B. came to own a fleet of 300 trucks and one of the most successful road construction, earth moving and disaster debris collection companies in the Southeast. With his tremendous business success, J. B. was generous beyond belief. Many buildings, baseball fields, parks and scholarships bear his name in our community.

A founding Seamark Board Member, J.B. was active in all construction ensuring Seamark held to its "no debt" policy, a value shared by J.B. Most recently J.B. was helping guide Seamark's plans to raise funds and build more homes to serve even more children in the future.

J.B.'s impact on all who were blessed to know him is evidenced by the hundreds who paid tribute to him with a gift to Seamark Ranch. J.B.'s generosity and faithfulness will continue to transform the lives of Seamark children for generations.
